## Owner privileges (In the period when the owner is not renounced)

- Owner can unauthorize addresses.
- Authorized address can authorize other addresses.
- Authorized address can include and exclude from fees.
- Authorized address can change the stak and liquidity fee.
- Authorized address can change stak and liquidity addresses.
- Authorized address can change the liquidity router.
- Authorized address can change the maximum transaction amount.
- Authorized address can transfer all balance from contract.

Smart contracts contain owner privileges. LP pair contract is not checked.
